2. HAZARD IDENTIFICATION

EMERGENCY OVERVIEW: Product Description: DDVP resins extruded in red plastic. **Health Hazards:** Routes of entry: Ingestion, inhalation, and absorption through the eye or skin are all possible routes of entry for this active ingredient. Exposure by any of the routes may cause acute cholinesterase depression. Severe cholinesterase depression may be fatal. **Flammability Hazards:** This product is flammable under certain conditions. Dichlorvos emits acrid smoke and fumes of HCL, phosphorous oxides and carbon oxides when heated to decomposition. The polymeric dispenser may produce CO, CO₂, HCL and CL₂ when burned. **Reactivity Hazards:** This product is stable under normal conditions/not reactive. **Environmental Hazards:** This product may cause harm to the environment if released, avoid leakage into the environment. **Emergency Response Procedures:** Emergency responders must wear the proper personal protective equipment (and have appropriate fire-suppression equipment) suitable for the situation to which they are responding.

4. FIRST-AID MEASURES

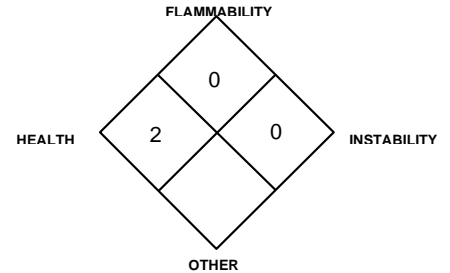

6. ACCIDENTAL RELEASE MEASURES

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED: Individual strips that are pouched, pick up and place in a sealed container. If strips are unpouched, and decontamination is warranted, decontaminate the area with dilute ammonia (less than 5% solution) and detergent. Flush the area with water. Absorb the rinse water using an absorbent such as, but not limited to clay, sawdust, straw or kitty litter and sweep into an open drum. Close the drum and dispose as hazardous waste. SIGNS OF CHRONIC OVEREXPOSURE: Repeated exposures to small doses of DDVP and other organophosphates may lower the cholinesterase to levels where the symptoms of acute overexposure are observed.

ORGAN TOXICITY: Dichlorvos primarily affects the nervous system through cholinesterase inhibition, the blockage of an enzyme required for proper nerve functioning.

EFFECTS ON BIRDS: Dichlorvos is highly toxic to birds, including ducks and pheasants; the LD50 in wild birds fed dichlorvos is 12 mg/kg.

EFFECTS ON AQUATIC ORGANISMS: UV light makes dichlorvos 5 to 150 times more toxic to aquatic life. Grass shrimp are more sensitive to dichlorvos than the sand shrimp, hermit crab, and mummichog. The LC50 (96-hour) for dichlorvos is 11.6 mg/L in fathead minnow, 0.9 mg/L in bluegill, 5.3 mg/L in mosquito fish, 0.004 mg/L in sand shrimp, 3.7 mg/L in mummichogs, and 1.8 mg/L in American eels. The LC50 (24-hour) for dichlorvos in bluegill sunfish is 1.0 mg/L. Dichlorvos does not significantly bioaccumulate in fish.

EFFECTS ON OTHER ORGANISMS: Dichlorvos is toxic to bees and all insects.

4. FIRST-AID MEASURES

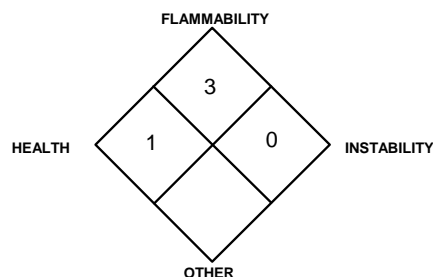
UNUSUAL FIRE AND EXPLOSION HAZARDS: This product is a Class IB flammable liquid. Can form vapors that form explosive mixtures with air at, or above, -4.4°C (24°F). Vapors of this product are heavier than air and may spread long distances; distant ignition and flash-back are possible. This product can float on water; therefore, water contaminated with this product can spread the flammable liquid and can spread fire. Vapors can accumulate in confined spaces, resulting in a toxicity and flammability hazard. Closed containers may rupture violently when heated. When involved in a fire, this product may decompose and produce toxic gases (including carbon monoxide, carbon dioxide, acetic acid and ethanol).

Explosion Sensitivity to Mechanical Impact: Not sensitive.

Explosion Sensitivity to Static Discharge: Probably will not accumulate static charge, since it has a high electrical conductivity (greater than 10(5) pS/m). Vapors in the flammable range may be ignited by a static discharge of sufficient energy (minimum ignition energy = 0.46 millijoules).

6. ACCIDENTAL RELEASE MEASURES

SPILL AND LEAK RESPONSE: Trained personnel using pre-planned procedures should respond to uncontrolled releases. Proper protective equipment should be used. In case of a spill, clear the affected area and protect people. Eliminate all sources of ignition before cleanup begins. Use non-sparking tools. Combustible vapor levels must be below 10% of the LEL for Ethyl Acetate (LEL = 2.0%) before personnel are permitted to enter the area. STABILITY: Stable. May slowly hydrolyze to acetic acid and ethanol in the presence of water.

DECOMPOSITION PRODUCTS: *Thermal:* When exposed to high temperatures this product will ignite and produce carbon monoxide, carbon dioxide, acetic acid and ethanol. *Hydrolysis:* May slowly hydrolyze to acetic acid and ethanol in the presence of water.

MATERIALS WITH WHICH SUBSTANCE IS INCOMPATIBLE: Ethyl Acetate is incompatible with strong oxidizing agents (i.e. peroxides, nitrates and perchlorates); contact will increase the risk of fire and explosion. Ethyl Acetate is also incompatible with strong acids, lithium aluminum hydride and potassium butoxide.

HAZARDOUS POLYMERIZATION: Will not occur.

CONDITIONS TO AVOID: Contact with incompatible materials and exposure to water, heat, sparks and other sources of ignition.

11. TOXICOLOGICAL INFORMATION

SYMPTOMS OF OVER-EXPOSURE BY ROUTE OF EXPOSURE: The most significant routes of occupational overexposure are by inhalation and skin and eye contact. The symptoms of over-exposure to this product are as follows:

INHALATION: In humans, exposure to 400 ppm for 3 to 5 minutes causes irritation to the nose and throat. Symptoms such as tension, tiredness, complaints and annoyance have also been reported during 4- or 8-hour exposures to 400 ppm. Severe exposures may produce signs of central nervous system depression such as shortness of breath, headache, drowsiness and dizziness. Congestion of the upper respiratory tract, spleen and kidney and hemorrhaging in lung tissue have been observed. Inhalation of high concentrations of vapors (as may occur if this product is used or released in a poorly-ventilated area or confined space, or during a release of large volumes of this product), may be fatal.

CONTACT WITH SKIN or EYES: Direct contact of this product with the skin may cause mild irritation. Prolonged contact with the liquid may cause dermatitis (inflammation, reddening and swelling). Eye contact of concentrated vapors of this product will cause immediate irritation and pain. Contact with the liquid and the eyes can cause severe irritation, pain, and redness.

SKIN ABSORPTION: Skin absorption is not a significant route of exposure for Ethyl Acetate.

INGESTION: Ingestion is not anticipated to be a significant route of over-exposure for this product. If this product is swallowed, symptoms may include nausea, vomiting, shortness of breath, headache, drowsiness, dizziness and other signs of central nervous system depression. These effects may be caused in part by ethanol which is released when ethyl acetate is broken down in the body. A significant hazard associated with ingestion of this product is via aspiration; aspiration of this material into the lungs can cause severe lung irritation and tissue damage, which can result in the development of chemical pneumonia or pulmonary edema (which are potentially fatal conditions).

INJECTION: Injection is not anticipated to be a significant route of over-exposure for this product. If this product is "injected" (as may occur through punctures by contaminated, sharp objects), local swelling and irritation can occur.

HEALTH EFFECTS OR RISKS FROM EXPOSURE: An Explanation in Lay Terms. Over-exposure to this product may cause the following health effects:

ACUTE: Inhalation of vapors from this product can cause headaches, nausea, dizziness, drowsiness, confusion, and unconsciousness and moderate irritation of the respiratory system. Inhalation of high concentrations of the vapors can be fatal. Ingestion of large volumes of this product can be harmful or fatal. Aspiration of the liquid can cause potentially fatal conditions of pulmonary edema or chemical pneumonitis. Direct eye contact may be irritating. Skin contact may be mildly irritating.

PERSISTENCE AND BIODEGRADABILITY: The following data are available for Ethyl Acetate.

Persistence and Biodegradability: If released to air, a vapor pressure of 93 mm Hg at 25°C indicates Ethyl Acetate will exist solely as a vapor in the ambient atmosphere. Vapor-phase Ethyl Acetate will be degraded in the atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is estimated to be 9.4 days. Volatilization from moist soil surfaces is expected to occur based upon a Henry's Law constant of 1.34×10^{-4} atm-cu m/mole. Ethyl Acetate's vapor pressure indicates the potential for volatilization from dry soil surfaces exists. Biodegradation is expected to be an important process in both soil and water, based upon Ethyl Acetate's biodegradation in aqueous screening studies. 93% biodegradation was observed in a complete mix continuous-flow activated sludge system. 26.6 and 57.1% of Ethyl Acetate's theoretical BOD was reached in 5 days using the standard dilution method and seawater dilution method, respectively. If released into water, Ethyl Acetate is not expected to adsorb to suspended solids and sediment in water based on the estimated Koc. Volatilization from water surfaces is expected to be an important fate process based on Ethyl Acetate's Henry's Law constant. Estimated volatilization half-lives for a model river and model lake are 8.9 hours and 5.6 days, respectively. An estimated BCF of 3.2 suggests the potential for bioconcentration in aquatic organisms is low. Ethyl Acetate's hydrolysis half-life at 25 deg C and pH 7 is 2.0 years.

Dusts and mists whose LC₅₀ for acute inhalation toxicity is greater than 2 mg/L but less than or equal to 10 mg/L. Materials whose LD₅₀ for acute dermal toxicity is greater than 200 mg/kg but less than or equal to 1000 mg/kg. Materials whose LD₅₀ for acute oral toxicity is greater than 50 mg/kg but less than or equal to 500 mg/kg. Any liquid whose saturated vapor concentration at 20°C (68°F) is equal to or greater than one-fifth its LC₅₀ for acute inhalation toxicity, if its LC₅₀ is less than or equal to 5000 ppm and that does not meet the criteria for either degree of hazard 3 or degree of hazard 4. Compressed liquefied gases with boiling points between -30°C (-22°F) and -55°C (-66.5°F) that cause severe tissue damage, depending on duration of exposure. Materials that are respiratory irritants. HEALTH HAZARD: 3 (materials that, under emergency conditions, can cause serious or permanent injury): Gases and vapors whose LC₅₀ for acute inhalation toxicity is greater than 1,000 ppm but less than or equal to 3,000 ppm. Dusts and mists whose LC₅₀ for acute inhalation toxicity is greater than 0.5 mg/L but less than or equal to 2 mg/L. Materials whose LD₅₀ for acute dermal toxicity is greater than 40 mg/kg but less than or equal to 200 mg/kg. Materials whose LD₅₀ for acute oral toxicity is greater than 5 mg/kg but less than or equal to 50 mg/kg. Any liquid whose saturated vapor concentration at 20°C (68°F) is equal to or greater than one-fifth its LC₅₀ for acute inhalation toxicity, if its LC₅₀ is less than or equal to 3000 ppm and that does not meet the criteria for degree of hazard 4. Compressed liquefied gases with boiling points between -30°C (-22°F) and -55°C (-66.5°F) that cause frostbite and irreversible tissue damage. Materials that are respiratory irritants. Cryogenic gases that cause frostbite and irreversible tissue damage. Materials that are corrosive to the respiratory tract. Materials that are corrosive to the skin. **4** (materials that, under emergency conditions, can be lethal): Gases and vapors whose LC₅₀ for acute inhalation toxicity less than or equal to 1,000 ppm. Dusts and mists whose LC₅₀ for acute inhalation toxicity is less than or equal to 0.5 mg/L. Materials whose LD₅₀ for acute dermal toxicity is less than or equal to 40 mg/kg. Materials whose LD₅₀ for acute oral toxicity is less than or equal to 5 mg/kg. Any liquid whose saturated vapor concentration at 20°C (68°F) is equal to or greater than one-fifth its LC₅₀ for acute inhalation toxicity, if its LC₅₀ is less than or equal to 1000 ppm.

FLAMMABILITY HAZARD: 0 Materials that will not burn under typical fire conditions, including intrinsically noncombustible materials such as concrete, stone, and sand: Materials that will not burn in air when exposed to a temperature of 816°C (1500°F) for a period of 5 minutes in accordance with Annex D. **1** Materials that must be preheated before ignition can occur. Liquids that have no fire point when tested by ASTM D 92 Standard Test Method for Flash and Fire Points by Cleveland Open Cup, up to a boiling point of the liquid or up to a temperature at which the sample being tested shows an obvious physical change. Combustible pellets with a representative diameter of greater than 2 mm (10 mesh). Solids containing greater than 0.5 percent by weight of a flammable or combustible solvent are rated by the closed cup flash point of the solvent. Most ordinary combustible materials. **2** Materials that must be moderately heated or exposed to relatively high ambient temperatures before ignition can occur. Materials in this degree would not under normal conditions form hazardous atmospheres with air, but under high ambient temperatures or under moderate heating could release vapor in sufficient quantities to produce hazardous atmospheres with air: Liquids having a flash point at or above 37.8°C (100°F) and below 93.4°C (200°F) (i.e. Class II and Class IIIA liquids.) Any liquid or gaseous materials that is liquid while under pressure and has a flash point below 22.8°C (73°F) and a boiling point below 37.8°C (100°F) (i.e. Class IA liquids). Materials that ignite when exposed to air. Solids containing greater than 0.5 percent by weight of a flammable or combustible solvent are rated by the closed cup flash point of the solvent.

INSTABILITY HAZARD: 0 Materials that in themselves are normally stable, even under fire conditions: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) below 0.01 W/mL. Materials that do not exhibit an exotherm at temperatures less than or equal to 500°C (932°F) when tested by differential scanning calorimetry. **1** Materials that in themselves are normally stable, but that can become unstable at elevated temperatures and pressures: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) at or above 0.01 W/mL and below 10 W/mL. **2** Materials that readily undergo violent chemical change at elevated temperatures and pressures: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) at or above 10 W/mL and below 100 W/mL. Materials that in themselves are capable of detonation or explosive decomposition or explosive reaction, but that require a strong initiating source or that must be heated under confinement before initiation: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) at or above 100 W/mL and below 1000 W/mL. Materials that are sensitive to thermal or mechanical shock at elevated temperatures and pressures. **4** Materials that in themselves are readily capable of detonation or explosive decomposition or explosive reaction at normal temperatures and pressures: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) of 1000 W/mL or greater. Materials that are sensitive to localized thermal or mechanical shock at normal temperatures and pressures.

FLAMMABILITY LIMITS IN AIR:

Much of the information related to fire and explosion is derived from the National Fire Protection Association (NFPA). **Flash Point** - Minimum temperature at which a liquid gives off sufficient vapors to form an ignitable mixture with air. **Autoignition Temperature**: The minimum temperature required to initiate combustion in air with no other source of ignition. **LEL** - the lowest percent of vapor in air, by volume, that will explode or ignite in the presence of an ignition source. **UEL** - the highest percent of vapor in air, by volume, that will explode or ignite in the presence of an ignition source.

TOXICOLOGICAL INFORMATION:

Human and Animal Toxicology: Possible health hazards as derived from human data, animal studies, or from the results of studies with similar compounds are presented. Definitions of some terms used in this section are: **LD₅₀** - Lethal Dose (solids & liquids) which kills 50% of the exposed animals; **LC₅₀** - Lethal Concentration (gases) which kills 50% of the exposed animals; **ppm** concentration expressed in parts of material per million parts of air or water; **mg/m³** concentration expressed in weight of substance per volume of air; **mg/kg** quantity of material, by weight, administered to a test subject, based on their body weight in kg. Other measures of toxicity include **TDLo**, the lowest dose to cause a symptom and **TCLo** the lowest concentration to cause a symptom; **TD₀**, **LDLo**, and **LD₀**, or **TC**, **TCo**, **LCLo**, and **LCo**, the lowest dose (or concentration) to cause lethal or toxic effects. **Cancer Information**: The sources are: **IARC** - the International Agency for Research on Cancer; **NTP** - the National Toxicology Program, **RTECS** - the Registry of Toxic Effects of Chemical Substances, **OSHA** and **CAL/OSHA**. IARC and NTP rate chemicals on a scale of decreasing potential to cause human cancer with rankings from 1 to 4. Subrankings (2A, 2B, etc.) are also used. **Other Information**: **BEI** - ACGIH Biological Exposure Indices, represent the levels of determinants which are most likely to be observed in specimens collected from a healthy worker who has been exposed to chemicals to the same extent as a worker with inhalation exposure to the TLV.

ECOLOGICAL INFORMATION:

EC is the effect concentration in water. **BCF** = Bioconcentration Factor, which is used to determine if a substance will concentrate in lifetimes which consume contaminated plant or animal matter. **TL_m** = median threshold limit; Coefficient of Oil/Water Distribution is represented by **log K_{ow}** or **log K_{oc}** and is used to assess a substance's behavior in the environment.
