#### I UNDERSTAND THAT:

1. Hand-held Launchers and Bird Banger, Screamer Siren, Bird Banger EXP, ShellCracker and CAPA cartridges are for use in wildlife pest control **ONLY**.
2. Instructions for proper use are furnished with each product.
3. In these instructions, Forestry Suppliers, Inc. recommends the use of ear and eye protection with all pyrotechnics. Protection devices are available through Forestry Suppliers, Inc..
4. According to ATF regulations, Bird Banger EXP, ShellCracker, and CAPA cartridges must be stored in a Type 2 ATF-approved storage magazine. All pyrotechnics should be stored to prevent access by children or unauthorized persons, and they should be stored in a cool, dry, non-residential location. Pyrotechnics should be stored in original packaging, and inside a locked metal container with a non-sparking interior.
5. Forestry Suppliers, Inc. shall not be held responsible for any injury resulting from the use or handling of these devices whether or not used in accordance with directions.
6. The buyer agrees to secure Federal, State and local permits as required.
7. The buyer of explosive products must be twenty-one (21) years of age or older.
8. The buyer hereby accepts said material subject to all terms hereof.

Please be advised that all Forestry Suppliers, Inc. sales records for pyrotechnics and related shipping documents are available to, and are subject to examination and review by the U.S. Department of Justice Bureau of Alcohol, Tobacco, Firearms and Explosives, the U.S. Department of Transportation, and the U.S. Consumer Product Safety Commission.
